Between the hours of 7:00 a.m. and 7:00 p.m. on Monday April 27, 2020 and ending on Tuesday, April 28, 2020.





ORDINANCE # 1093

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GRAHAM, TEXAS ORDERING AN ELECTION TO BE HELD ON SATURDAY, MAY 2, 2020 FOR THE PURPOSE OF ELECTING ONE (1) MAYOR AND TWO (2) ALDERMEN; ESTABLISHING THE DATES AND PLACE FOR VOTING; ESTABLISHING APPLICATIONS FOR BALLOTS BY MAIL; ESTABLISHING DEADLINE FOR RECEIVING BALLOTS BY MAIL; ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the laws of the State of Texas and the Charter of the City of Graham, Texas establish the requirement for the ordering and conducting a municipal election; and

WHEREAS, in accordance with the City Charter, on May 2, 2020 the registered voters of Graham may elect one (1) Mayor and two (2) Aldermen; and

WHEREAS, provisions for early voting and applications for ballots by mail are established in the formal Order of Elections; and

WHEREAS, the City Council enacts the Order of Election and establishes an effective date for this order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAHAM, TEXAS:

SECTION 1; The City Council hereby orders to be held on Saturday, May 2, 2020 an election for the purpose of electing one (1) Mayor and two (2) Aldermen to serve a two year term of office beginning after the proper canvassing of the vote, acceptance of canvass and the swearing into office those individuals elected by the registered voters of the City of Graham.


SECTION 2; The official polling place for the Municipal election on May 2, 2020 shall be the North Central Texas College, 928 Cherry Street, Graham, Texas 76450 and the polls shall be opened from 7:00 a.m. to 7:00 p.m. on that day.

SECTION 3; Early voting by personal appearance will be conducted each weekday at North Central Texas College at 928 Cherry Street, Graham, Texas 76450 between the hours of 8:00 a.m. and 5:00 p.m. from April 20, 2020 to April 24, 2020 and between the hours and 7:00 a.m. and 7:00 p.m. on April 27, 2020 and April 28, 2020.

SECTION 4; Applications for ballots by mail shall be mailed (or by fax to 940-221-2104) to Lauren Sullivan, 516 Fourth Street, B-1, Graham, Texas 76450. Applications for ballots by mail must be received no later than the close of business on April 20, 2020.

This ordinance becomes effective immediately upon passage by a majority vote of Aldermen present at the time of consideration.
