

ORDINANCE NO. 1167

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GRAHAM, TEXAS ('CITY') CANCELLING ORDINANCE NO. 1165 ORDERING A GENERAL ELECTION TO BE HELD ON SATURDAY MAY 4, 2024, FOR THE PURPOSE OF ELECTING ONE (1) MAYOR AND TWO (2) COUNCILMEMBERS (PLACES 1 AND 2); DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE; ORDERING THE POSTING OF THIS ORDINANCE AT CITY HALL AND POLLING PLACE(S) ON ELECTION DAY; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the election is for officers of the City in which each candidate whose name is to appear on the ballot is unopposed, and

WHEREAS, the filing deadline for name placement on the ballot and declaration of write-in candidacy have passed, and

WHEREAS, the City Council has received the City Secretary's written certification that each candidate is unopposed for the election, and

WHEREAS, in this circumstance, Section 2.053(a) of the Texas Election Code authorizes the governing body to declare each unopposed candidate elected to office and to cancel the general election thereby avoiding the expenses related to holding a general election and saving public funds.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAHAM AS FOLLOWS:

SECTION 1. The general election for the purpose of electing one (1) Mayor and two (2) Council Members (Places 1 and 2) previously called for Saturday, May 4, 2024, is hereby canceled.

SECTION 2. The following candidates, who are unopposed for the May 4, 2024 general election is hereby declared to office and shall be issued a certificate-of-election at the regularly scheduled City Council meeting following the date on which the general municipal election for one (1) Mayor and two (2) Council Members (Places 1 and 2) was to have been held:



SECTION 3. The City Secretary shall post a copy of this ordinance at City Hall and on Election Day, the Young County Elections Administrator shall post a copy of this ordinance at the polling place(s).

SECTION 4. Should any word, sentence, paragraph, subdivision, clause, phrase, or section of this ordinance or of the Code of Ordinances, as amended hereby, be adjudged, or held to be void or unconstitutional, the same shall not affect the validity of that remaining portions of said ordinance of the Code of Ordinances, as amended hereby, which shall remain in full force and effect.

SECTION 5. This Ordinance is administrative in nature and required under Texas Elections Code. The Council determines that it is in the public interest to waive three readings of this Ordinance to enable timely execution of the cancellation described herein. Therefore, this Ordinance shall take effect immediately upon adoption in accordance with the provision of the Charter of the City of Graham, noting the waiver of three readings; and it is so ordained.
